- Acquisition by Gestmin, on 11 January 2018, of 212,675.00 ordinary shares of CTT on Euronext Lisbon (XLIS) at the average price of €3.8519/share;
- Acquisition by Gestmin, on 12 January 2018, of 170,000.00 ordinary shares of CTT on Euronext Lisbon (XLIS) at the average price of €3.6666/share.

Hence, following these transactions, Gestmin currently holds, directly, 18,260,787 (eighteen million two hundred sixty thousand seven hundred eighty-seven) shares representing 12.17% of the share capital of and voting rights in CTT.
